## I. Terms of payment

### 1. General provisions

Aeronautical charges are payable to the SMAEDAOL before any take-off.

In case of non-payment, the invoice will be sent to the user plus a lump sum for billing costs of 5.60 € without VAT; This lump sum does not exempt any recovery and litigation costs provided for below.

However, some users may not be subject to this obligation and to the billing costs and are then invoiced periodically:

- Customers based or having premises on the airport concession,
- Regular customers who have expressly requested it and who have been granted of SMAEDAOL approval, approval which the latter has the right to withdraw at any time,
- Customers whose fees are taken into account by accredited consignees,
- Customers who only made "Touch and go" flights over the period expired.

### 3. Settlement period

Invoices are payable in cash

### 4. Penalties in case of delay

Any invoice issued by the Loiret airport during the month, which has not been settled before the 30<sup>th</sup> of the following month, will be forwarded to the Loiret departmental office for relaunch.

In accordance with Law 92.1442 of December 31<sup>st</sup>, 1992 as amended, this recovery may be subject to a late payment penalty calculated on the whole of the amounts due and at an interest rate equal to 3 times the interest rate legal.

After a second relaunch, worthy of formal notice, the file is sent to the Service litigation of the Departmental Office of the Loiret.

## 5. Pre-litigation and litigation

In the event of non-payment or insufficient payment of airport charges or the charge for terminal air traffic services, the aerodrome operator or the competent authority of the State may, after informing the person liable for payment Regularize the situation, request the seizure of an aircraft operated by the person liable for payment or belonging to it to the judge at the place where the measure was carried out.

The enforcement judge's order shall be transmitted to the air traffic authorities of the aerodrome for the purpose of immobilizing the aircraft. The order shall be notified to the person liable and to the owner of the aircraft when the liable for payment is the operator.

The costs of the provisional seizure shall be borne by the liable.

The payment of sums due involves the raising of the seizure.

## II. Aeronautics fees

### 1. Preamble

It is up to customers to inform the SMAEDAOL services of any modification to their fleet: purchases, sales, rentals, leasing, changes in aircraft characteristics, etc., under penalty of being charged according to the known characteristics of the airport.

Rates are quoted in Euros and are exclusive of VAT.

### 2. Application of VAT

VAT on airport services (landing, marking, parking, passengers, fuel charges) is invoiced at the normal rate in force.

The system for applying VAT to these benefits has been defined by the bill Finance December 19<sup>th</sup>, 1978, summarized in the table below.

### 3. Remarks

#### French companies

To benefit from the exemption, French companies are required to provide to the SMAEDAOL services with a valid certificate for the current year, certifying that their services in international traffic represent at least 80% of the services they operate.

In the absence of this attestation, the Loiret airport will apply VAT to its invoices at the normal rate. In this case, no regularization of invoices already issued can be made and the exemption from VAT will only be effective from the date of dispatch of the certificate, the postmark being the proof.

#### Foreign companies

To qualify for the exemption, foreign airlines are required to provide a valid "Air Operator Certificate"

#### Chartered aircraft or flights made on behalf of another airline

In all cases, the application of VAT depends on the regime to which the company is subject, which is invoiced for airport services.

#### 4. Landing fees

<sup>1</sup>The landing charge shall be calculated on the basis of the maximum take-off weight on the aircraft's certificate of airworthiness, rounded up to the top ton.
